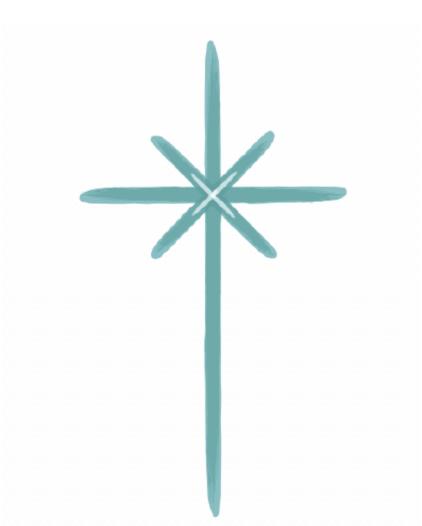

# EPIPHANY ANGLICAN CHURCH OTTAWA Minutes of the February 19, 2023 Vestry Meeting

1. The Rev. Simone Hurkmans declared the 26th Annual Vestry Meeting in session with an opening prayer at 12:10. Prayers were added for the following recently departed members of Vestry: Jane Derick, Jocelyne Blackie, Laurene Cullen, Michael Dove, Lynn Bennett, Tom Ritchie. "Rest eternal grant unto them, O Lord, and let light perpetual shine upon them."

2. Vestry Clerk: Wasseem Fayad moved, Catriona (Kitty) Galt seconded the appointment of Cindy Hurst Boyd as Vestry Clerk. Carried

3. The Vestry Declaration was read:

"I solemnly declare that: I am a member of this congregation of the Anglican Church of Canada; I am of the full age of sixteen years; I am a regular worshipper with this congregation; I do not intend to vote as a member of any other Vestry in the election of Churchwardens or of Members of Synod during the ensuing year; and I am a supporter of this congregation by regular contributions to its maintenance."

The declaration was agreed to and signed by 44 people present in person.

4. The minutes of the Epiphany Vestry Meeting of February 20, 2022 are found on pages 4 to 6 of the Epiphany Year 2022 Report to Vestry document. Discussion on the Minutes: a few errors were noted:

- On page 4 "Appointment of Vestry Clerk Rev Arran appointed Cindy (not Church) Hurst Boyd...
- On page 5 it should ready Kitty (Catriona) Galt for Deputy Warden
- On page 4 add Anne Fairlie to Attendees
- On page 7 the names of the deceased for September 17 should read William Thomas Sparling as he was known as Tom

Derek Keane moved, Roxanne Latulippe seconded the approval of the Epiphany Vestry Meeting of February 20, 2022 Vestry Meeting. Carried.

5. The Epiphany Incumbent's Report is found on pages 8 to 9 of the Epiphany Year 2022 Report to Vestry document. The Incumbent shared the following additional comments:

- Rev Simone shared that although it has been 2 ½ months since she joined us it feels much longer, in a good way. Thank you for the warm welcome to both me and my family. With the help of Cindy, Gennaro, Daniel, Rachelle and Melvyn, just to name a few, my transition has been made seamless.
- Epiphany has been through quite a bit in 2022 and yet we are full of hope and life. Thank you to all our wonderful volunteers, it is great to see the dedication and marvellous way in which everything happens. We need to be conscious of our volunteers and assist them when needed to avoid burnout. The Parish Council will be looking at this issue this year.

- In response to questions on my vision as CEO of Epiphany it should be noted that I am not CEO of Epiphany but a member of the Corporation of Epiphany. My role is to listen to you, the members of Epiphany and to God and model our vision around what I learn. In the 2 <sup>1</sup>/<sub>2</sub> months I have been here I have listened and have heard very little from parishioners about the proposed development project that was heard about at the open house held in August. I plan to have an intentional time of discernment during the 6 weeks of Lent - we will have a time of silence each Sunday for individual prayer and listening to God. If at the end of Lent the low enthusiasm for this project is confirmed, we will take that as our answer and not have a vote. It will show that at this time it is not a project for us but maybe in the future. We would then proceed with the needed repairs to our existing building.
- Please note that my door is always open to hear your concerns or visions.

6. The Epiphany Financial Reports for 2022 are found on pages 12 to 21 of the Epiphany Year 2022 Report to Vestry document. Gregg Alexander introduced the report with the following comments:

- It was noted that on page 12 Church and Contents reflects the book value and not the current market value
- On page 14 our Capital Fund has grown due to receiving a large insurance rebate on repairs done to the exterior of the building and to the fact that last vestry it was moved that we transfer \$1000/month into the capital fund from general operations
- On page 20 the total expenses shows what it actually cost to run the church, (\$215,706) in 2022. This was below budget due to the fact that we did not have an incumbent for most of the year and our proposed programs did not begin as soon as expected due to lingering concerns with COVID and waiting for our new incumbent to begin.
- It was highlighted that our general offerings were well below budgeted income
- Explained that on page 19 "other expenses: miscellaneous" were above budget as we had several gifts of appreciation and as there is no line item to record this expense it was tracked here.
- Simone expressed her thanks and ours to Gregg for his many hours of diligent work in tracking our finances.

Moved by Gregg Alexander, seconded by James Menard, "that the Epiphany 2022 Financial Report be accepted as presented." Carried

7. The Budget for 2023 is found on pages 23 to 29 of the Epiphany Year 2022 Report to Vestry document. Gregg Alexander introduced the Budget for 2023 with the following comments:

- 2023 will see an increase in the costs of running the Church our portion for Fairshare has gone up as well as the cost of insurance. Fairshare is calculated on a rolling 3 year average. For the last three years we have benefitted from a low assessed income in 2018 due to capital expenses and the salary costs of two priests. Since 2018 no longer counts in our three year average, our Fair Share cost has significantly increased for 2023.
- Salaries for our paid staff were increased by 4% over last year
- We anticipate all our programs to be running for the full year

- We have added a line item for expenses for Worship
- Simone pointed out that ECOPS does not reflect her salary. ECOPS is the equalization of the cost of priestly services within the Diocese the total cost of diocesan priestly services is divided by the number of churches based on their annual income. This equalized cost allows more experienced priests to serve congregations that may not otherwise be able to afford them. We at Epiphany have an income above the average diocesan churches average and therefore receive a higher cost of ECOPS.
- This is a deficit budget of \$36,106. It is a concern of our treasurer that although we have a healthy bank balance at the end of 2022 and can "cover" the deficit this cannot be allowed to continue.
- Gregg explained that the cost of snow removal is lower in 2023 as the contract begins in November of 2022 and concludes in April 2023; therefore we paid more in 2022 than budgeted for due to the overlap of contracts. We have a new snow removal company and they cost more (our previous snow removal company shut down).
- Expenses for children and youth ministry is to cover youth events that we have not had in past years. The school curriculum is shown under church school expenses.
- It was noted that we have a lot to be thankful for, great leadership with Rev Simone, greater
  participation but concern that we cannot or may not see enough of an increase in offerings to
  offset the deficit. With this in mind have we explored other options such as amalgamation
  with other churches? This was explored at the time of our "shape of parish ministry" and
  although we indicated we were open to this there was no action taken on our offer. We have
  created a new council position "Income" and this will be looked into.
- It was suggested that we might follow "microdonations" such as the grocery stores do when the customer is asked to donate \$2 towards various charities; we at Epiphany could instead donate those \$2 to our church.
- It was noted that our snow removal company this year is doing a great job. Our emergency exits, should they be needed, are clear of snow and ice.

Gregg Alexander moved, Roxanne Latulippe seconded, "that the 2023 Budget be accepted". Carried

8. The 2022 Committee Reports are found in the Epiphany Year 2022 Report to Vestry document on pages 30 to 45. Comments on these reports included:

- Simone commended the reports to everyone; please read they will make you feel good about all the work that has been accomplished despite a challenging year
- Thank you extended to all who wrote the reports and to Cindy for ensuring all reports were received and included in the circular

Gillian Keane moved, Shelley Harvey seconded, "that the 2022 Committee Reports as found in the Epiphany Year 2022 Report to Vestry document be accepted as published." Carried

9. The Nominations Committee Report for 2023 is found on pages 46-47 of the Epiphany Year 2022 Report to Vestry document. The Incumbent thanked Judith Young, Laurence Sianchuk and Kitty Galt for their assistance on the Nominating Committee. The Incumbent called for changes or further nominations:

- Thank you to Judith, Heather and Kitty (Catriona) for their huge commitment to this parish. Corporation has done a lot in this time of transition: hired a new musician and Sunday School Leader; created committees and job descriptions, structured parish council; had all of this in place in time for our new incumbent which was and is greatly appreciated.
- Thank you to our outgoing warden, Judith Young. A gift of appreciation was presented to Judith, a Jasmine plant.
- No one presented themselves or nominated anyone other than those listed in the nominations. Welcome to our new Parish Council.
- It was questioned whether our Sidesperson Coordinator should in fact be a nominated position believe it to be in the diocesan canons. Corporation will look into this.

Sandy Harris moved, Jennifer D'Aoust seconded, "that the report of the Nominations Committee 2023 be accepted as published." Carried

10. Communion Lay Administrators for 2023:

Rev. Simone indicated that Communion Lay Administrators no longer need to be approved by Vestry. However, she noted that a list of the Epiphany's current Communion Lay Administrators can be found on page 47 of the Epiphany Year 2022 Report to Vestry document.

11. Signing Authorities for Epiphany's Bank Accounts:

Derek Keane moved, Rose Dennis seconded, "that the Reverend Simone Hurkmans, Gregg Alexander, Heather Howley, Catriona (Kitty) Galt and Laurence Sianchuk be signing authorities on bank accounts for Epiphany Anglican Church, held in the Alterna Savings financial institution". Carried

12. Auditor/Review of the Books for 2023:

- Gregg noted that our books for 2022 have been audited and we have received the report that all was found to be in good order.
- We will send her a note of thanks and a gift of appreciation, Roxanne mentioned that Stephanie does not wish to receive anything.

Gregg Alexander moved, Rachelle Dube-Hayes seconded, "that Corporation be authorized to appoint an Auditor or appropriate person(s) to Review the Books for 2023". Carried

• Gregg noted that Stephanie Miller has agreed to be our auditor once again in 2023.

#### 13. Other Business

a) Adult Education: Don Leek noted that 14 people have been attending the Simply Jesus study that will conclude in April. He asked that we consider a possible study for the fall; one possible topic could be a study on the Epistles of St Paul. Please speak to Don or Rev. Simone with topic ideas.

b) Judith reported that according to the Diocesan Regulation R5.09: "At each annual meeting of the Vestry of a congregation, there shall be elected by the Vestry or appointed by the Churchwardens a Convenor of Sidespersons, whose duty it shall be to establish a roster of Sidespersons for the ensuing year; and the Convenor of Sidespersons so elected or appointed shall hold office until the annual meeting of the Vestry next following his or her appointment". Based on this clarification, Corporation will be appointing a Convenor of Sidespeople (Jos Cleary) at its next meeting.

c) Front Door Automatic Opener: it was noted that our front door is no longer handicap accessible as the automatic door opener is not working. This repair and the repair of our church sign has been put on hold until a decision is made about the building project (partnership with Andrew Fleck) Question: when will we be doing these repairs? Reply: We will have a decision by Easter on the plans for the building.

d) Possible income idea: install charging stations for electric cars. Idea will be passed onto the Income Chair to investigate.

e) Update from Outreach Committee (Wasseem) - we are looking at developing the strip of land near the storage shed into a vegetable garden. We will be looking for gardeners for advice and volunteers to weed the garden. A suggestion put forward that we might look into indoor hydroponic towers as a year round way for gardening. Jennifer D'Aoust and Emma Gazaleh work at schools that have begun doing this. The Outreach Committee will investigate.

14. Adjournment at 1:15 pm.

Rose Dennis moved adjournment of the 2023 Vestry Meeting. Carried

# Incumbent's Report

A voice cries out: 'In the wilderness prepare the way of the Lord, make straight in the desert a highway for our God. Every valley shall be lifted up, and every mountain and hill be made low; the uneven ground shall become level, and the rough places a plain.' *Isaiah 40:3-4* 

#### Dear Epiphany,

This verse comes to mind as I reflect on the past year and look to what might be ahead for us. Much of what we've done over the last twelve months has been about preparing the way of the Lord and making the rough places a plain. At this time last year we were getting to know each other and considering whether to embark on a substantial development project that might have involved adding on to or demolishing our worship building. We spent Lent in intentional discernment and felt that God was calling us to focus on five priorities:

- 1. Repairing our current building so that it can continue to serve our congregation (particularly our children and youth) and our neighbours;
- 2. Increasing our income through increased use of our current space;
- 3. Increasing our givings through rejuvenated stewardship efforts;
- 4. Growing our membership, and;
- 5. Continuing to serve those most vulnerable in our community.

In the past year we've come a long way towards these goals and have laid much groundwork for stability and growth. Highlights have included: significantly higher attendance at our Sunday services including new and returning young families, a thriving Thursday evening study group, a new Income Committee, the restarting of the Pastoral Care team, the awarding of a United Way grant used to purchase new cameras to improve our online worship experience, Bishop Shane's visit and confirmation of six young people and one adult, wonderful fellowship at our Trivia Night and Christmas Craft Sale, extensive efforts to create a Request for Proposals to repair our building, the application for the private sponsorship of a refugee from Eritrea, and an amazing Celebration of New Ministry complete with a flash mob (!) among many, many others. There were also a few challenges: vandalism, break-ins and theft, financial strain due to increased expenses from inflation and offerings not returning to pre-pandemic levels, and the heartbreaking loss of dear friends.

We have a wonderful team at Epiphany who guides us through the highs and lows of parish life. Thank you to Cindy who is a wealth of knowledge and wisdom for me and the whole community. Rachelle's energy and ideas attract and engage young people. Gennaro's talent for music and technology keeps us inspired and connected each week. As we get to know Daniel more, we recognize that his gifts include more than music, his quiet compassion is a blessing to all. And of course Melvyn's steady service keeps our building welcoming for all those who worship here. I am wary to name volunteers as we are blessed with so many that I am sure to accidentally leave someone out. I will only name the members of our Corporation who have served with such wisdom and energy over the last year. Heather, Kitty, Laurence and Gregg: thank you for your wisdom, support and humour.

I am grateful to all of you for making Epiphany what it is: a warm, welcoming, open-minded and open-hearted spiritual home for all, including me, John, Isabelle, Evelyne and Hugo. I am excited about what this next year will bring. We have so many ways we can prepare the way of the Lord in our community and in our neighbourhood, let's get to it!

Our first year with Rev. Simone and her family - what a blessing for us. It has been a year of welcome, "getting to know" and moving forward. We had a couple of back steps - 2 break-ins and an act of vandalism but moving forward we have an enhanced security system with cameras and a doorbell camera.

We secured a grant to enhance our on-line worship. We are participating in a guided workshop to increase our sense of belonging as a congregation and we will have a new website. We have had an increase in baptisms and in November we had 7 confirmations. The summer saw us "bring a friend to church" These are all signs of growth.

We planted a tree, a programme of PWRDF. A matching tree will be planted in Uganda. We built raised beds and grew vegetables! We continue to explore our community and what our role and contribution could be. Rev Simone leads us in this with prayer and discernment.

On the financial front we have a challenge. We had a Stewardship campaign but we are still falling short. \$20.000. We have all the signs of a growing and vibrant community but the traces of Covid linger and we have not returned to pre- Covid income yet. The diocesan Covid relief is no longer available and our costs continue to rise - just like ours at home!

Our attendance is up. We have a wealth of dedicated volunteers and a treasure of talents. This is our home and we have much to be thankful for.

### Description of Financial Assets

Part of our financial assets includes two investment trust funds held by the diocese.

- The Rectory Trust Fund (proceeds from the sale of the rectory) and
- The McElroy Trust Fund (an endowment from a parishioner).

Both remain unchanged from last year. They generate dividend income which appears in the general operations fund. The financial statement from the Diocese regarding these two trust funds follows the treasure's vestry report.

The rest of our financial assets include a bank account, a short-term GIC, a prepaid credit card and petty cash maintained by our office administrator. These assets decreased in 2023, from \$147,976 to \$132,477. We manage these cash accounts in 7 funds as follows:

# Description of our Funds

The Extra Parochial Fund holds directed donations from parishioners to registered charities. In June and December all funds were sent to these charities.

The Sunday School Fund was set up at the start of the year in memory of Jane Derick. Money collected amounted to \$5,125.

The Refugee Sponsorship Fund was set up in August for a private sponsorship. The money was provided by a parishioner. This money will be doled out in 12 monthly payments starting when the refugee arrives in Canada.

The Capital Fund holds funds for major acquisitions and repairs to our building and furnishings. Expenses incurred were for security cameras to mitigate against vandalism and theft.

# Report on Past Year Financial Operation of the Church

The General Operations Fund manages all the money to run the church. In February 2023, vestry approved a deficit budget. This fund started the year with \$91,455 and ended with \$38,555- a more significant loss than was planned by the budget for 2023.

- Income Highlights:
  - Offerings were \$12,394 below budget.
  - Offerings are far below the level seen in 2019.
  - Rental income was \$7,784 below budget.
  - Many renters have left.
  - McElroy Trust Fund dividends owed to the church did not arrive in December, but will be credited in January 2024 instead.

- Fellowship and fundraising events provided more income than expected.
- Overall income was \$12,111 below budget.
- Expenses Highlights:
  - Unlike in the previous three years, the diocese granted no reductions to our assessed costs in 2023.
  - Most planned programs started up in 2023 and spent their budget allocations.
  - Due to the excessive amount of snow in the early part of 2023 we were forced to pay penalties.
  - Unplanned spending occurred to deal with vandalism and theft.
  - We were no longer allowed to have parishioners lead Sunday service to fill in for our priest's absences.

The table on the next pages provides details of income and expenses for running the church for the past year. The first two columns of numbers in the table show actual and planned income and expenditures by category for the approved budget. Bracketed numbers in the third column highlight shortfalls in income or overspending in expenses.

# Offerings Report

There are various methods of financially contributing to support the work of our church: Automatic Monthly Giving (PAR), e-transfers (epiphanyanglican@gmail.com), weekly envelopes or Canada Helps. You may join any method at any time.

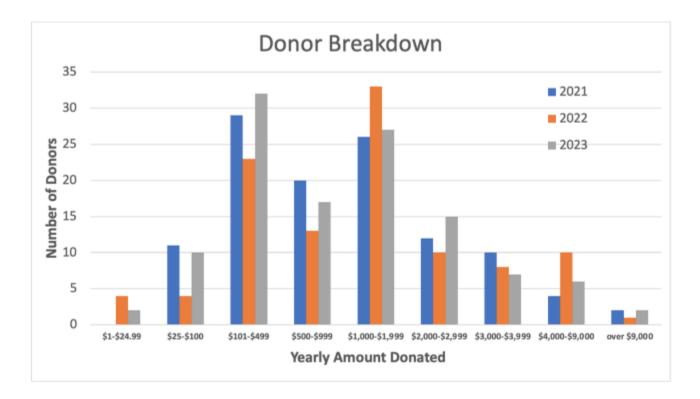
The PAR (Pre-authorized Remittance) is very easy to join: you simply ask one of the sidespeople for a form or email the office (office@epiphanyanglican.ca); fill it out and return to the office along with a voided cheque and on or around the 20th of each month your contribution is withdrawn and deposited into the church account; no more remembering to bring your envelope to church or do "catch up" for your vacation times. You may adjust or stop your monthly donation by submitting a written request to the envelope secretary.

E-transfers are an easy way to support the work of Epiphany and there is currently no administration cost. You make your contribution online; it is deposited directly into the church's bank account and you get either an email or text message confirming your transaction. Send e-transfers to epiphanyanglican@gmail.com

If you wish to begin using weekly church envelopes, extra boxes of envelopes are available from the sidespeople. To begin, simply fill out the accompanying paper and place it in your first envelope. Each box of envelopes contains blue monthly envelopes which are directed to PWRDF; weekly white envelopes where you can indicate general offering or directed offering (directed could be for memorial flowers, or one of our outreach areas like the Emergency Food Cupboard); special seasonal yellow envelopes for extra donations at Easter, Thanksgiving and Christmas and one envelope to donate towards the cost of offering these envelopes (note that you must ensure your envelope number is recorded in the spot provided).

Canada Helps is an on-line donation and the link can be found on our web page. Canada Helps issue tax receipts for donations made through them and I issue tax receipts for all other methods of identifiable donations in support of the work of our church. Please ensure that the office has your correct Canada Post mailing address. Note that Canada Helps keeps a portion of your givings as an administrative fee.

The following is a breakdown of all donations received in 2023: There were 118 donors contributing to the work of Epiphany Anglican Church through the use of PAR, E-transfers, Weekly Church Envelopes & Canada Helps. We also issued tax receipts for donations from 20 guests.



# Proposed Budget for the Operations of the Church in 2024

- This is a deficit budget.
- Income Highlights:
  - Parish Council proposes a large increase in offerings.
  - Only total offerings are budgeted, not a breakdown.
  - Our Stewardship campaign resulted in 29 pledges & about \$12,000 of increased offerings.
  - Since this is not enough, the stewardship campaign will undertake a second phase in 2024 to increase offerings by another \$20,000.
  - Increases in hall rental and parking revenues are predicted by the income committee as they find new renters.
  - We should see two years' worth of dividends from McElroy Trust fund credited in 2024.
  - Targets for fundraising are increased.
- Expense Highlights:
  - Our large expenditures are fixed by the diocese.
  - Transferring money to the capital fund will decrease from \$1000 to \$500/month.
  - A Sunday school/youth worker salaried position is to continue in 2024.
  - Some programs will have reductions in their budget.
  - This budget foreshadows challenging times ahead as we contemplate taking on a mortgage.
- The table below presents the proposed budget for running the church in 2024. The actual and budgeted amounts for 2023 are repeated here for comparison.

# Children & Youth

Children & youth usually start together and praise with song and/or dance.

Once the songs are done, the lessons take place:

• January through June 2023 - the Story Keepers helped the children learn stories about Jesus.

• During Lent, we also followed "The Road of Lent" and had lively discussions about topics such as thankfulness, forgiveness and abstinence.

- September to November 2023 the story of Moses was taught.

Main responsibilities of the committee

What we wanted to prioritize in 2023:

- Revamping Epiphany's website
- Building up a bank of great and good photos
- Continuing our presence on Facebook and Instagram

#### Our goals for 2023:

- 1. Secure vendor to help with revamping website
- 2. Revamp structure of website
- 3. Select new web hosting provider and content management program to replace Wix
- 4. Choose template for website
- 5. Write new, short, evergreen content
- 6. Launch new website

We are well on the way to achieving these goals.

We researched web hosting companies and selected a new one: WHC. We are using WordPress. We transferred the domain from Rebel.ca to WHC (the domain cost will be covered by WHC). We paid for three years of web hosting and got a 40% discount.

We found a designer, who helped us select a template and is now putting the site together. We developed a new structure for the site. The content is 90% written.

Rev. Simone hired a photographer to take professional photos, which we uploaded to WordPress. We continue to take amateur photos to supplement the excellent professional ones.

We aim to complete work on the new site by the end of February.

Creative Connections resumed in June 2022 after the major COVID restrictions. We had an average of 10.5 persons in attendance over 22 weeks.

In 2023 we recorded an average of 15 (15.59) persons over 47 weeks. The lowest attendance has been 8 and the highest, 20 people on any given week. The most popular activity is playing cards (euchre or crib); knitting as such has lost popularity and has given place to other artisanal venues. Parish members and other attendees still provide knitted and crocheted products for Centre 454. We donated over 50 knit or crocheted hats, many knit by our dear friend, Anne Crossley. We also have over 30 knit or crocheted lap afghans that we hope to deliver to one of our local seniors' residence.

Consider dropping by Tuesday morning between 10 and noon and join us for a cup of coffee or tea and some lively conversation.

### Finance

- 1. The finance committee meets when needed to review and comment on proposals for expenditures exceeding \$5,000. Members include the treasurer, the people's warden, the office administrator, and a parishioner named by Corporation (currently Hon Lam).
- 2. We met in April to review the proposal to upgrade our video equipment to enhance the online experience. We conducted an email meeting in September to review the new contract for snow removal. In both cases the proposals were given a green light.

### Income

What we did:

- A literature search (and Ron's ChatGPT search!) did not uncover anything too surprising. Best ideas were signing up *regular* customers who would rent the church (like social groups who meet regularly; and other churches who meet regularly but not on Sunday) vs. pursuing 'one-offs'. Some churches hold cultural series at their church as a means of advertising and serving the community.
- Our comparison of best practices in raising income within the Anglican Church in Ottawa found that regular renters (including daycare at Trinity) and carefully planned Christmas themed events (bazaars (St. Aidans) and auctions (St. Matthews)) generate a lot of revenue.

- Interviews of people at Epiphany connected with generating income showed: no-one feels deluged by income requests now (i.e., we could handle more bookings); and people are generally keen to raise income. The Committee questions why Epiphany folk who do 'catering' work (which is often implicated in revenue-generating events) aren't reimbursed but other revenue-assisting work (set-up and cleaning) is.
- Talked to UofO to see if an MBA student would work for us for free (keen but not for free!)
- Informal consults with the congregation after two services indicate that people want revenue-generating events to be interesting and fun so they feel comfortable inviting (non-Epiphany) friends and get some revenue from them. Ideas included wine tasting, square dancing and trivia night.
- We advertised daily parking through: direct emails to CSEC and CSIS; (boosted) social media posts and our external sign. Little uptake resulted (mostly because government employees still enjoy working from home flexibility). Direct advertising through CSEC and CSIS was most effective.
- We developed a user survey to ask church renters what they thought of us and how we could improve.
- We did a survey of rental rooms and parking spaces in the area: we're comparable for parking and on the lower end for daily rates for space but relatively high for hourly rates.
- We worked with congregation members who had **event ideas** that were also revenue-generating (e.g, with G. Keane for Trivia Night).
- We also worked on the Kanata Soup Fundraiser.
- We prepared the grant that raised over \$35K for Epiphany.
- We consulted with the Diocese about: the economics of charging stations; their previous compilation of grants and foundation awards; and other income ideas of other parishes.
- We helped with Epiphany's website update so we have a professional and inviting info page about renting our space (with nice photos) for a: party; Life Celebration; arts event; etc. We've got catering prices for three 'levels' of food (from simple BBQ to lavish). The ideal would be a 'one-stop shop' for an event. We would look after everything for a set fee per person (depending on guest needs). Takes advantage of having Rev. Simone who is receptive to officiating at non-Anglican events.

- We costed and spoke to caterers (e.g., Epicuria) who could provide Epiphany renters with catering options (from basic to gold level) for an event like a funeral. This would provide us with rapid ability to mount events and provide renters with options.

What we recommend:

- Use Google as an advertising means so people looking for rental space can easily find us. It looks promising and we'd be at the forefront of local churches (so we could come up as first choice).
- Consider a park 'n ride shuttle service for people who park at Epiphany and go to nearby offices or park and use the LRT to head downtown. We are also discussing with the shuttle bus owner who takes local government employees from parking lots to their offices to see if they could swing by Epiphany. We have looked at insurance should an Epiphany volunteer need to step in for a day.
- Follow-up with every church renter with a satisfaction survey
- Offer the church standard hourly rate for folks who help with catering at events. They may well choose to give their pay back to the church but it would be their choice.
- Find renters who have significant ongoing weekly needs.
- Try to make it easy for renters to mount events (like a Celebration of Life). We could suggest caterers (depending on their budget) and arrange as much as we could in the background.
- Recognize that parking is a solid moneymaker and advertise directly through CSIS and CSEC.
- Find out what our renters want by using the feedback form.

# Outreach

The Outreach committee did a lot over the course of 2023. We started the year off strong with a grocery store gift card program which has disbursed nearly \$1,000 in grocery store gift cards to people in need of assistance both within our parish and in the wider community. The program has been a success in providing these funds in a confidential manner designed to maintain the dignity of all who ask for our help. We would like to recognize and thank Rev. Simone for her assistance in distributing these cards in a manner in keeping with these values.

We built two garden beds to provide food and pollinator-attracting plants, with plans to donate the produce to the Gloucester Emergency Food Cupboard once we are capable of producing a significant quantity of food. We would like to recognize Duane Van Alstine and John Lasseigne for their help in building these two beds. We plan to build two more beds this coming warm season. We would also like to recognize Rachel Dube-Hayes for putting in the work to seed and plant our crops and for using the garden beds as an enrichment activity for our Sunday School and our parish at large.

At Thanksgiving of 2023, the parish of Epiphany donated nearly 100 pounds of food to the Gloucester Emergency Food Cupboard, which is something that we can all be proud of and we thank the parishioners of Epiphany for their generous donations.

In addition, we worked with Valerie Maier in her capacity as our parish's PWRDF contact to promote the PWRDF's Seeds of Hope program and we thank her for her continued support of the Outreach committee both in this capacity and as a member of the committee."

## The Interchurch Refugee Group (a subcommittee of Outreach)

### Annual Report for our supporting congregations – January 2024

This report is offered with thanks to our supporting congregations: Community Pentecostal Church, Epiphany Anglican Church, Orleans United Church, Rothwell United Church, and Navan-Vars United Church. Your prayers, your willingness to volunteer, your commitment to the refugee ministry, and your financial support, have been our backbone, and we are grateful. The refugee-themed worship services at three of our member churches this past year also allowed us to give thanks together for the ministry to refugees and newcomers to which we are all committed.

IRG volunteers had a "massive" year in 2023. The Syrian family of five sponsored directly by the IRG through the Blended Visa Office-Referred (BVOR) program, arrived on December 22, 2022; and that sponsorship will conclude on January 31, 2024. In addition, since November 2022, groups of us have been assisting a young Congolese woman, two Afghani sisters, and an Iranian woman to settle in Canada. The first three are in partnership with Lamp Lifeboat Ladder, and the fourth is a co-sponsorship with an Orleans family through the Anglican Diocese.

In a BVOR sponsorship, the government pays for six months of the family's financial support. The IRG pays the other six months, as well as the cost of setting the family up initially with housing and furniture, and basic needs. The IRG was responsible for all the settlement support, with tasks ranging from getting documents, the language assessments and school registration, to accompanying family members for doctor's appointments.

It is important to note that every sponsored refugee newcomer who comes to Canada, has a sponsor. And that sponsor is responsible for financially supporting the newcomer for a minimum of one full year. Only the Syrian family of five is being financially supported by the IRG. But the volunteer settlement support for that family, and the four young women, has been a great labour of love, generosity, and commitment. Our volunteers are angels!

In addition to this direct settlement work, the IRG also prepared and successfully submitted the sponsorship application for the husband of one of the Syrian family members. This will be a direct sponsorship by the IRG, both financially, and for settlement support.

We also continue to wait for the Palestinian man we are sponsoring. We are optimistic that he will arrive by the summer, 2024.

This year was exceptional for fundraising. In addition to our regular and deeply appreciated gifts from congregations and donors, we received a large donation of \$15,000 to which we were challenged to "match." This led to us raising over \$30,000 this past year, meaning that all the money for our next two sponsorships—the Syrian man and the Palestinian man, are in the bank, with some left over to initiate another family BVOR sponsorship down the road.

The Interchurch Refugee Group is deeply appreciative of the faithful gifts of all its supporters. Without your time, money, and prayers, nothing could be accomplished.

#### 2023 IRG donations

Here are the donations received from our supporting churches and directly from congregants of these churches during the 2023 calendar year. (These amounts do not include the small fees that Canada Helps deducts for donations made through their webpage.)

These donation amounts also exclude the amazing support we received from our volunteers and supporting congregations for our three big 2023 fundraisers: the Great Glebe Garage Sale in May raised \$1,500.25, the Gordon Lightfoot inspired musical fundraiser hosted by Scott Richardson and Robin Guy at Orleans United Church in June raised \$1,400, and the Sacred Dance Guild's HumanKind performance at Britannia United Church in December raised \$342. There were also donations made through Canada Helps, totalling \$750 that coincided with a wonderful fundraising letter prepared and sent out by Gerry Dust from Navan Vars United in late November. We are also fortunate to receive financial support from people in the community, and not connected to our supporting churches, that are not reflected here.

As you know, in late Spring we received an offer to match all IRG donations received by the end of September to a maximum of \$15,000. We were close to matching this amount at the end of September and our donor happily agreed to extend her matching offer to the end of December 2023. We are thrilled to share that by the end of December we had received matching donations totalling \$15,000 plus over \$1,600 more. 2023 has been the best year ever for fundraising for the IRG. Thank you to everyone for the incredible support.

## Property

The Property and Building Committee had a very active year in 2023. The Committee was comprised of Ron Zimmer, Duane Van Alstine, Philip Jago, Wasseem Fayad, Jos Cleary, Ken Amesbury, Charles Maier, Reverend Simone Hurkmans, and Laurence Sianchuk. Special thanks go to the Church Council, Cindy Hurst-Boyd, and many others who assisted the Committee in 2023.

The Committee undertook many tasks and some of the major activities were:

- 1. The Committee engaged and discussed plans for incorporating a daycare centre and a senior housing facility, into the Parish. The final decision of the Parish of the Epiphany was to not proceed at this time, but potentially at some point in the future.
- 2. With this decision, the Committee began the process to find a contractor(s), through an RFP process, to deal with the building envelope, ventilation system, extension of the roof, replacing the main sign, and installation of a backflow valve.
- 3. There was also work started on developing a strategy to generate funds from foundations and grants for the expected costs associated with the building upgrades.
- 4. The main sign received a "face lift" to fix the ongoing deterioration.
- 5. There was involvement in the Green Sacred Spaces Program and the Energy Benchmark initiative.
- 6. Melvyn Douglas, under contract, continues to handle the building cleaning and grass mowing.
- 7. Work took place on adding the new video and sound system.
- 8. There was work done to remove broken eavestroughing and repair leakage issues with the roof and windows.

- 9. This past year there were trespassers and two break-ins. There was great communication with the City Administration and the Police Services and other efforts took place to resolve these issues.
- 10. Steps were taken to add motion sensor lights and cameras to the building as well as a video doorbell.
- 11. Due to massive amounts of snow, Sunshine Snow Services Inc.did a good job in clearing it, but there were additional costs. A contract extension was finalized and the extra fees were spread over future years.
- 12. Vehicles, such as Blood Services' trucks, were driving on the front walkway and damaging it. A new policy is now in place, that vehicles are no longer allowed on the walkway and stations were added to the walkway to assist with this new policy
- 13. Storage in the building has been an issue and steps are being taken to find more storage.
- 14. There was a collective effort, by many parishioners, to assist with the spring and fall cleanup, plant care, removing dead trees, and yard maintenance.

There were many other tasks and work undertaken by the Committee and many volunteers, which was truly appreciated. The Committee thanks everyone on the Council and in the Parish of the Epiphany, for their continued help and support. If anyone wishes to join the Committee, please contact the Wardens or me.

## Stewardship

Committee Members: James Menard took over as Committee Chair in 2022. Other members are Rev. Simone, Gregg Alexander, Susan Liddle, Heather Howley and Cindy Hurst-Boyd. We welcome input from parishioners on stewardship matters and are always open to new members.

Stewardship, fundamentally, is taking care of God's creation. In the context of the Church of the Epiphany, stewardship is managed through advice to the Parish Council on the best use of parish assets and resources, whether property, talent or money.

In 2022 we continued to benefit from revenue resulting from the *Every Perfect Gift* campaign that resulted in a significant increase in financial commitments from parishioners, as reported in last year's Vestry Report. Therefore this has been a quiet year for stewardship at Epiphany.

That said, there has been a noticeable decline in the amounts contributed via envelope collections, which have not kept pace with the operations budget agreed at Vestry, and expenses are rising significantly due to inflation. Details are given in the Treasurer's Report. Nor have the few fundraising events held over the past year managed to completely fill the gap. This situation has led to consideration of possible solutions, and 2023 will see the launch of a new campaign to address this need.

Legacy giving is another donation option that has not been promoted at Epiphany of late, so this year will see increased focus on this method of leaving a lasting gift.

Stewardship of our parish building and grounds is led by the Property Committee, a dedicated team of volunteers devoted to keeping Epiphany neat, tidy and in good working order. We also continue to practice energy conservation, recycling, composting and sustainable gardening.

# Synod

Another year has sped by resulting in another Synod gathering of our Anglican Diocese. I here present you with another Synod Vestry Report for 2023.

Our parish had great representation this year from two Synod reps, and Reverend Simone who helped in the preparation of the SPMC Action Plan which we have now adopted. During Synod 2022 the attendees resoundingly approved SPMC Proposal Two, which included the development of guides and training for parish leadership. The 143rd Synod was started with the Eucharist Service at Christ Cathedral in which the Bishop's charge referenced the first and second letter of Paul to Timothy that gave guidance to the early Church pointing to the importance of proper administration. This was a fitting introduction to the SPMC Action Plans.

The Synod Circular began the following day with a full attendance of parish Synod representatives from the ADO. The gathering focused on parish development as laid out in the SPMC Eleven Actions Plan developed from the SPMC 2022 initiative. Areas of discussion centered on equipping congregations with the core knowledge and skills that are essential to thriving - particularly during times of significant change.

These plans included providing readily accessible training videos that would be available to every parishioner in the diocese. Topics will initially address 5 Key areas, Parish governance, building healthy communities, visioning and priority setting, effective stewardship and engaging the wider community.

Along with several other diocese related administrative activities, the stand out event of the first day of the Synod Circular was the reflections by Reverend Canon Richard Sewell, Dean of St George's College in Jerusalem. He conveyed his experiences and challenges faced operating an Anglican parish in a long standing conflict zone.

On the final gathering of the Synod Circular of 2023, we started with Reverend Canon Dr PJ Hobbs who gave a moving speech entitled "State of the Streets" describing the dire conditions of some of the neighborhoods in the diocese, and how the ADO plans to address these issues. This was followed by several more administrative discussions about the diocese, and then we went into the 'Listening for Divine Sparks in our Midst: A Time of Prayer' Action in which the Time of Prayer initiative was introduced (and carried out).

Dean Sewell's final reflection was the last event of the Synod Circular. His reflection centered on his perspectives of spirituality as it relates to one's world view, reflecting on how people in the Middle

East and Europe view and practice their spirituality compared to people in North America or the "New World" as he referred to it.

All in all, I believe the Synod 2023 gathering went exceptionally well. I feel confident that parishes within the Anglican Diocese of Ottawa will be able to initiate the revitalization initiatives that are presented in the SPMC Eleven Actions Plan.

Music and A/V (a subcommittee of Worship)

#### Choir Membership and Activity

2023 was a "normal" year, with choir activity back to pre-pandemic levels and a roster of 21 regular members. In addition to the usual services, the choir also sang at Rev. Simone's Celebration of New Ministry in April. On December 17th, we sadly lost long-time choir member and friend, Dan Elmose. The choir sang at his memorial service in January 2024 and collected funds to purchase a hydraulic piano bench in memory of his passion for music at Epiphany.

July marked Daniel Furtado's first year as organist/pianist at Epiphany. We have been blessed to have such a talented accompanist, soloist, and collaborator with us.

#### Worship Band

The Worship Band debuted in May 2023 on Pentecost Sunday and played at 5 services over the year. With electric and acoustic guitars, electric bass, cajon drum, flute, and piano, the Worship Band provides increased variety in the style of music we can offer.

#### Music Programming

We continue to feature music in a variety of styles and from a variety of sources. We strive to be more inclusive in our music selections through:

- Preference for more gender-neutral language in hymns and psalms
- Increased diversity in composers, cultures, and languages in music
- Short introductions to composers of anthems included in bulletin

#### Music Spending

The music budget increased to \$1,500 in 2023 (up from \$1,000) to accommodate increases in streaming licensing costs (CCLI) and additional piano tuning costs. We purchased a Cajon drum for the Worship Band in June. In December, we had the piano tuned and fitted with a Dampp-Chaser, which is a humidity control system for the piano.

#### Audio/Video Equipment and Streaming

2023 saw a major overhaul of our Audio/Video and streaming equipment. Thanks to an anonymous donation, we were able to purchase a new digital soundboard. The United Way grant allowed us to purchase a new Windows laptop for streaming and to engage Professional Sound and Lighting (PSL) to provide and install two Pan-Tilt-Zoom (PTZ) cameras, greatly increasing the versatility of our streaming.

Wasseem Fayad has amazingly taken the lead on running our 10:30 service live streams each week and has begun to train additional volunteers. Goals for 2024 include recruiting and training more A/V volunteers and establishing a rotating schedule for Sunday services.

# Nominations Committee

Your Nominations Committee for 2024 was made up of Kitty Galt, Heather Howley, Laurence Sianchuk, Gillian Keane, and Rev. Simone Hurkmans, and was directed by Parish Council to:

- Conduct check-ins with each member of Parish Council and ask about their intent to return for 2024.
- Establish length of terms for Parish Council.
- Identify roles that need to be filled and suggest appropriate candidates for these roles. Reach out to the candidates to determine their availability and willingness to serve in these roles.

### Check-Ins

Simone approached members of Corporation, while Heather approached other members of Parish Council about their intent to remain in their role the next year.

### Terms

Corporation established a 3-year term for Wardens, where they rotate through the three roles: year 1 - Deputy\*, year 2 - People's\*, year 3 - Rector's. This creates stability in Corporation and allows new members to grow into the role. Synod representatives'\* serve a 2-year term as set by Diocesan regulations.

\*As these are elected positions, these roles require a vote at Vestry.

Nominations decided not to set terms for remaining Parish Council positions. The current approach works well, and Nominations will continue to ask members of Parish Council, prior to Vestry, about their intent to return next year.
